

As the chart shows, as long as your account holds sufficient funds, you can participate in the contract-options game.

What are contract options? They are trades where you use a set time limit to predict the price direction of a given contract instrument. If the contract moves in your predicted direction and, at the end of the time period, remains [above your entry price for a long position or below your entry price for a short position] then your option trade is successful.


It was a tragedy, a heartbreaking tragedy! It was not only a political event, but a heavy reckoning for the soul of each of us!

I believe many new participants in currency surfing draw their foundational understanding of the crypto world from the stock market, let's make some horizontal comparison:

When you hold a U.S. stock account;

Lvl 1: You must complete strict KYC requirements, including proof of address, identity information, wealth details, and employment information;

You then complete some basic test trades;



After that, you need to upgrade to a Lvl 2 account activation, which requires a minimum deposit of \$2k

If you wish to unlock additional functions, you must deposit more funds, for example, to enable margin trading, short selling, or intraday trading privileges.

All Lvl 2+ unlocks are achieved through additional deposits!

Similarly, in the crypto market, there are Lvl 2 account upgrades as well, so, if you are currently facing restrictions, it is not the result of intentional limits by the platform, but simply because you have not chosen to upgrade your account. I believe that as long as you follow the instructions provided by the official account manager to meet these requirements, you will complete a full account unlock!

Compliance in 2025 is a critical regulatory initiative for the crypto market. Whether from the three major crypto bills passed by Congress, or from SEC enforcement requirements, including feedback reports under MSB licensing supervision, all of these mandate that the INDEXBIT crypto trading center complete the necessary account upgrades.

Anti-Money Laundering, or AML.



AML refers to a comprehensive set of laws, regulations, procedures, and tools designed to prevent money laundering—the process of disguising illegally obtained funds (for example, money from drug trafficking, corruption, or fraud) as legitimate.

Imagine, criminals steal \$1 million in cash. They cannot simply walk into a bank and deposit it, because it would be flagged.

But if they use that money to buy Bitcoin and then sell it back into regular currency, it can appear as though the dirty money has been "cleaned."

The purpose of AML is to close this loophole, making the financial system like a sieve—filtering out anything suspicious.

In simple terms: AML is like airport security. When you buy a ticket (trade crypto), you must go through security checks (identity + financial verification) to prevent anyone from bringing dangerous someting items (illicit funds) onto the plane.

This not only protects the passengers (ordinary users) but also the airline itself (the crypto platform) from fines or shutdown.



Under MSB licensing rules, crypto trading centers are required to comply with AML just as banks do.

Put simply, these platforms act as "gatekeepers." They must check whether incoming and outgoing "guests" are suspicious. And when you need to make a large transaction, please follow the guidance of the official customer service staff, who will assist you to successfully complete your trade or withdrawal!

Imposing AML acts as a "protective umbrella" for crypto services—
transforming this emerging market from "wild growth" into a
"regulated garden."

I hope this guide provides convenient assistance to new members of currency surfing!

At the same time, some members who have never held crypto reserves may wonder: how can they obtain quick settlement something services from P2P trusted merchants and safely, seamlessly convert traditional assets into on-chain assets?



First, P2P trusted merchants are officially certified by the crypto trading center and provide margin commitments. This currently ensures that every user can safely participate in conversions. When you settle, you don't need to worry about not receiving the equivalent amount of crypto assets. In fact, you may even receive the credited crypto assets in advance—though you must still fulfill the related fiat wire transfer.

For these specific procedural details, you will need the assistance of official staff, so, please contact the official customer service team promptly!

Of course, when you conduct settlements with P2P trusted merchants, you may sometimes encounter international wire



merchants. How should this be understood?

Based on my interpretation of official information and my own real experience, P2P national settlement merchants operate in a fully compliant and legitimate manner.

Think of it this way: when you order a product from Amazon that comes from Europe, Asia, or Africa, Amazon itself does not produce the item. You must complete the purchase through Amazon's certified merchants.

You pay the order amount, and then wait to receive the product.

In the same way, when you conduct an international wire transfer with a P2P merchant, perhaps involving partners in Asia or Africa, it reflects the fact that mining costs in those regions are lower. They obtain BTC at a lower cost, then convert it into USDC. Because of this lower-cost environment, they are able to provide you with better settlement exchange rates, which is ultimately to your sometime advantage!

Therefore, when using international wire transfers through P2P



settlement merchants, simply follow the guidance of official customer service staff. This is fully compliant and represents a legitimate settlement business. There is no need to worry—your traditional assets are secured in your on-chain account, and they will not disappear!
