And as we move into the late afternoon and early evening here on the U.S. East Coast, with the winter sunlight fading, we can't help but wonder, at what price will MPG make its debut?

Based on the information released by the official channels, we can now estimate with confidence that MPG's listing price will exceed 100 USDC.

This outcome is very much in line with our expectations. The earlier

surge in market demand and the intensity of the buying pressure made this trajectory obvious, there was no reason for us not to anticipate where it was heading. #When demand keeps rising while the number of circulating shares

stays fixed, the price you must offer to acquire them will only climb higher, otherwise, your order simply won't execute. #This is the price-increase phenomenon created by scarcity and aggressive buying.

So, when the number of shares of this stock is fixed, and the amount of capital chasing it keeps rising, the price of the stock will inevitably be pushed higher.

For example, if total demand reaches \$10k and exactly 100 shares of this stock are traded, the price per share is \$100

#When demand reaches \$100k, still for the same 100 shares, the price rises to \$1000 per share, the demand has increased 10x, and the stock price has risen 10x

#When demand climbs to \$300k, for the same 100 shares, the price becomes \$3000 per share, demand has grown 30x, and the stock price has risen 30x.

#So we can conclude that when 90M MPG tokens are chased by 9

billion dollars of demand, the price would rise more than 25x

#Because the quantity is fixed and rising demand inevitably pushes the price higher. This is precisely why MPG's projected listing price is expected to exceed \$100, do you see the logic now?

However, the exact official listing price for MPG will ultimately be determined by the announcement from the exchange!

My friends, at this very moment, as the MPG subscription officially comes to a close, we finally stand at a true milestone in this wealth journey—
